FRANKLIN COUNTY VISITORS BUREAU LAUNCHES FREEDOM TOURS

The Franklin County Visitors Bureau launched its first Freedom Tour of 2009 with the John Brown Franklin County Experience. Frederick Douglass, portrayed by living history interpreter Fred Morsell, recalled his visit to Chambersburg in August 1859 to meet with John Brown and recreated both his commitment to the anti-slavery movement and Brown's lifelong commitment to the cause. Dennis Frye, a noted John Brown historian, also spoke. Sites visited on the tour include Mary Ritner's Boarding House, Franklin County Old Jail, Emmanuel Chapel, Mont Alto State Park, and the capture site of John Cook, one of Brown's key men.

Upon arriving in Chambersburg on August 19, 1859, Douglass was recognized by the citizens of Chambersburg and pressed for the purpose of his visit. Douglass said he was in town to give a speech. The true reason for Douglass' presence was the meeting with John Brown. Shortly after his arrival, Douglass connected with Henry Watson, an African American barber in the community, who was known for his association with the Underground Railroad. Watson arranged the meeting of John Brown and Frederick Douglass, a key connection of Brown to the Franklin County Underground Railroad. Another connection between Brown and the local network of the Underground Railroad is Mary Ritner, whose boarding house is located on present-day King Street in Chambersburg, where Brown and his men head-quartered the northern location of the insurrection.

In an effort to solidify the Underground Railroad connection of the Ritner Boarding house, also known as the John Brown House, the Franklin County Visitors Bureau submitted an application of the Mary Ritner Boarding House/John Brown House to the National Park Service Network to Freedom on July 15, 2008. Two additional applications were submitted at the same time and six additional are planned for submission in December 2008.

The John Brown Sesquicentennial Tour launched a yearlong series of events and activities that commemorate the John Brown Sesquicentennial. The John Brown commemorations are the initial collaborations of four states—Maryland, Pennsylvania, Virginia, and West Virginia—and marked the first of several sesquicentennial events in the historic Great Valley region, including commemorations related to Abraham Lincoln, the Emancipation Proclamation, and the Civil War.

The Franklin County Visitors Bureau will offer and Underground Railroad Tour on September 27, 2009 and celebrate the PA Civil War Trails Discovery Weekend in Franklin County with the *Road To and Retreat From Gettysburg* on October 17-19. SUMMIT ENDOWMENT ANNOUNCES 2008 GRANT AWARDS SUMMIT ENDOWMENT–INVESTING IN TOMORROW'S COMMUNITY HEALTH AWARDS MORE THAN \$400,000 TO COMMUNITY-BASED PROGRAMS ADDRESSING HEALTH ISSUES

Investing in Tomorrow's Community Health has awarded more than \$400,000 to nine community-based, non-profit organizations for the 2008 funding cycle. This brings the total funding granted since the endowment's inception in 1998 to nearly \$3 million. Summit Endowment has supported more than 45 community-based, non-profit organizations to date.

The mission of the Summit Endowment is to support and encourage the development and success of programs of 501(c) 3 organizations addressing recognized health issues affecting residents of Summit Health's service area.

Grants for 2008, beginning July 1, 2008, were awarded to:

Fayetteville Elementary's Lewis & Clark Trail Project: Chambersburg Area School District Foundation to develop a walking and fitness program for 3rd through 5th grade students at Fayetteville Elementary School based upon the Lewis & Clark Trail Program in the Greencastle-Antrim School District.

Faust Hip-Hop Dance Club: Chambersburg Area School District Foundation to expand the after-school program offering an hour of tutoring/study time and an hour of hip-hop dance instruction twice a week for junior and senior high school students.

Franklin County 4-H Therapeutic Riding Program: to expand the Therapeutic Riding Program to provide targeted services for Autism Spectrum Disorder children and youth.

Lutheran Home Care Services to develop a pilot program to provide home Tele-health monitoring to residents of Franklin County who are living with chronic cardiopulmonary conditions.

Small Business Development Center Shippensburg University

Helping businesses start, grow, and prosper.

All businesses have one thing in common: Recordkeeping. Whether you are a large or small business, you must have a system in place to organize all the necessary supporting documents that are required for taxes, audits, and managing your business.

What does recordkeeping mean? Recordkeeping is maintaining accurate information that represents the transactions of your business and keeping this information on file for a specific period of time.

How is recordkeeping accomplished? Any item you record as a transaction must have supporting documentation. Following is a list of items that you should keep and the supporting documentation that is required:

Gross Receipts- These documents show the income to your business. Types of gross receipts are cash register tapes, deposit slips, invoices, credit card slips, 1099's.

Purchases – These documents are for items you purchase and resell to customers, or goods you buy to manufacture a product. Types of purchase supporting documents are receipts, cancelled checks, and invoices.

Expenses – These documents are for items that are necessary to carry on your business. Types of supporting documentation are cancelled checks, invoices, account statements, receipts, and credit card slips

Travel, Transportation, and Entertainment expenses - If you travel, keep all parking and toll receipts. If you deduct mileage on your car, record all travel miles from starting mileage to ending mileage along with the date traveled.

Assets – These documents support the property you use for your business, including machinery and furniture.

Employment Taxes- These supporting documents are Employer Identification Number, amount and dates of wages and tips, names, addresses, social security number of employees, dates of employment, W-2 returned undeliverable, copies of employee income tax withholding, date and amount of tax deposits, copies of returns filed, and records of fringe benefits.

Recordkeeping can be completed daily, weekly, or monthly depending on the volume of your business. If your business has multiple transactions daily, then doing your recordkeeping daily or once a week is a good idea. If you wait till the end of the month, you could miss important transactions that need to be recorded.

Common ways to manually complete recordkeeping include ledgers or a journal. Other options include computer software programs such as QuickBooks, Peachtree, and Quicken. QuickBooks offers a free sample of Simple Start 2008 CD that you can order or download at www.quickbooks.intuit.com. Or you can contact the Shippensburg SBDC for a free sample of the Simple Start 2008 CD at 717-477-1935 or sbdc@ship.edu.

Manager's Corner: Plot Your Plan

I was recently asked by an executive team, "How do we start pulling a Succession Plan together? We believe we have many of the pieces already, but we don't know what to do with them." That's a great question and a great position to be in. The answer though, requires you to first be clear on what you really want your Succession Plan to do for you. Once you're clear on that, you can then better appreciate how to start.

When most people think of Succession Plans, they imagine some document that outlines who's going to step up into a vacant spot when the current position-holder retires, moves up him or herself, or experiences the "hit by a bus" scenario - which is any emergency or unexpected situation that requires someone else to quickly step in temporarily or long-term. That singular focus type of plan is great and basically outlines who some of your "fall back" or "go to" people may be. That's good to know when you need to make a quick personnel decision.

The other and more comprehensive purpose for succession planning is to not only create the above document, but to also plan for acquiring, recruiting, or developing internally the skills your organization will need as it continues to move forward. So instead of just filling a spot with someone who can hold things together, you're creating depth and talent throughout your organization. This will allow you to have a pool of individuals with high-level, broad-based skills capable of filling one or more positions within your organization. This provides greater flexibility, increases employee knowledge and skills, and also increases employee commitment to the organization.

So, back to the initial question: "How do we starting pulling a Succession Plan together?" I'd suggest you follow four initial steps:

- 1. Plot Your Organization Chart Print out your organizational chart and list in each box the current position/position holder. Below that person's name, list the names of three to five people. List the names of anyone who could step in quickly at least on a temporary basis. Then, list the names of individuals who have the potential to be viable candidates for the position long-term -- if they have more time, training, and development opportunities. Print the names of anyone currently capable of stepping in and filling a position in black; print all other names in red. If you have no name to put in a spot, put "???" and print those in red too.
- 2. Assess Your Chart Review your color-coded organization chart. How much red are you seeing? Are you also seeing situations where you have one back-up person identified, but that person is planning to retire within the next few years? Do you have several positions where only one person knows or does the job and you simply don't have any other employees? In this type of situation, if you lose that person, who's going to do the work?
- 3. Prioritize Your Plan For any position boxes that have more red than black, highlight the box in yellow or some other obvious color.
- 4. Plot Your Plan Review the highlighted areas to determine "Hot Spots" or priority areas. These Hot Spots are areas or positions that need attention quickly to develop skills, transfer knowledge, initiate cross-training and mentoring, or at least document critical procedures.

Though the above is a quick overview, once you know what you have – or don't have – you're better able to know where to start in Succession Planning. Be clear on what you want the plan to do. Then use your organizational chart to plot the direction and immediacy of your plan. Plot your plan to your future success.
