The Authority stated that they would review her usage at the meeting following the meters being read. They stated that they would make the adjustment at that time. They would review her account and make the adjustment most likely at the January meeting.

MOTION: to Nominate and approve Daniel Chayes to fill the vacant position was made by Doug Hoffman, second by Catalin Bonciu, all ayes, motion carried.

Chairman Malone welcomed Dan as a member of the Authority and invited him to take his seat.

Chairman Malone asked Dawn Scheller for the Secretary's Report.

Dawn Scheller provided the Authority with information regarding tires needed for the backhoe. Dawn provided the Authority members with the quotes received. The cost of the tires would be paid from the Joint Equipment Fund. Dawn stated that the Water Authority authorized their third of the cost.

MOTION: to approve 1/3 of the total cost of \$1780.16 for a tire purchase of backhoe tires from Service Tire Truck Centers to be paid from the Joint Equipment Fund was made by Catalin Bonciu, second by Dan Chayes, all ayes, motion carried.

Chairman Malone reviewed the New Business.

The Authority reviewed the preliminary budget for 2012.
