Chamber Membership Terms and Conditions

- Chamber membership is a continuing commitment to economic growth and community betterment, and an investment in the Chamber's many efforts to promote the region and make it a more prosperous place to do business.
- Chamber membership is based on the number of salaried, hourly, or commissioned employees and equivalents (FTE*), including yourself working at the business, or other categorical match as described in Dues Schedule. 3 Part Time Employees = 1 Full Time Equivalent
- Chamber membership dues are tax deductible as an ordinary and normal business expense, not as a charitable contribution.
- If the company/business/organization is a member, all employees of same are permitted to attend and participate in Chamber functions and activities.
- Businesses are recognized by an EIN number. Cases of common ownership with different EIN numbers are treated as separate members.
- The Primary Representative of the member is the main contact for the chamber. This representative receives the annual renewal notice (due January 1st of every year), their name is listed in the membership directory, and serves as the main contact for all information about the member.
- Failure to remit membership renewal payment within 90 days of the renewal date will result in termination of all membership privileges.
- A chamber decal will be provided for display at member business for as long as membership is in good standing. The decal remains property of the chamber. A lapse of membership will require removal of decal.
- Chamber membership may be terminated at any time in writing by the member. There is no refund on, or transfer of Chamber membership.
