Discussion of Plant Manager Report- Jon Piper

1. Board's attention, one eDMR violation occurred – daily reading of 2.99 mg/l and 2.23 mg/l and our permit lowest limits is 5.0 mg/l. plant has nearly 525,000 gallons of waste/eater and 963,000 gallons pass through the plant.

2. Update on main Pump Station issues - reported last month – two or three pumps serviced or repaired
3. Alarm call Keefer Drive (Food Lion) Ramsey Septic contacted for assistance- pump would not hold prime nor function, JWP visited the Pump station multiple times over the weekend.
4. Reed bed #1 or #2 are not looking very healthy. Sampling of the reeds beds was performed
5. Both SBRs continue to have a good settling with abundant biological activity.
