Plant Manager Report – Plant Operations are going well, Work has been completed on filter #2 Effluent A value by PSI, Zimmwell is holding its own even with the dry weather, along with the reservoir we are running at 135gpm thru the plant, which is the most we've been able to run in the past 3 years. Chemical usage is way down due to mixing the 2 sources and using more from the reservoir than in the past. I would like to ask the authority to approve the purchase of a backup soda ash pump as we do not have one.
