Zoning Ordinance Amendment Hearing Called to Order

The Zoning Ordinance Text Amendment was duly advertised in the Mercersburg Journal on July 23, 2025 & July 30, 2025.

The Zoning Ordinance Text Amendment was submitted to the Franklin County Planning Commission and the Mercersburg Borough Planning Commission for review and comment.

Ordinance 6-24 is a text amendment amending the Zoning Ordinance by adding uses, definitions, and provisions related to solar energy systems.

The Mercersburg Borough Planning Commission has submitted proposed amendments and editorial changes to Ordinance 6-24 – Solar Energy Systems for approval. The proposed amendments are included in the meeting packet.

MOTION: To approve Ordinance 6-24 Solar Energy Systems with Planning Commission's editorial changes was made by Heefner, seconded by Burkot, all ayes, motion carried.

PUBLIC COMMENTS

Rick Frisby - Rick expressed concerns regarding several properties where wood from fallen trees and branches is being stockpiled. He noted that these piles attract unwanted wildlife. He emphasized that property owners should be held accountable for properly maintaining their lots to avoid such issues. Additionally, he raised concern about overgrown tree limbs extending onto sidewalks and streets in certain areas, creating obstructions that force pedestrians and vehicles to detour around them.

In response, Connie Creighton shared that the Borough is aware of the situation and is actively gathering data on affected properties. Steve Coccorese suggested the option of utilizing the International Property Maintenance Code (IPMC) as a foundation for establishing ordinances. Ordinances will be reviewed as part of ongoing efforts to address the issues as effectively as possible, despite current limitations in staffing and resources. Related Ordinance(s) will be provided for review at the next Council Meeting.

Staff will conduct a second walkthrough to confirm the accuracy of this list. Once verified, the list will be forwarded to Salzmann - Hughes so that notification letters can be sent to the non-compliant property owners. Following that, we can proceed with the next steps for repairing the sidewalks and curbs that have not been addressed.
