To approve the “acceptance” by Historical Architectural Review Board (HARB) for a roof replacement at 125 South Main Street. This work was carried out without a Land Use permit prior to project execution. Additionally, this property is in the Historical Architectural District and the required HARB review and approval prior to work commencing was bypassed. The HARB notes the metal roofing styles recommended in the Historical Architecture District are “standing seam” or “5V groove”; the installed metal roofing is in the “agricultural style”. The HARB notes the project is completed and replaces severely deteriorated roof material and therefore the HARB recommends the approval of this roof replacement.

This project involves the replacement “in kind” of a deteriorated asphalt shingled roof.
