He reviewed the JD Link which provides mechanical warning information to the PWD for the backhoe. He recommended the Authority to approve their share of the cost to be paid from the Joint Equipment Fund.

MOTION: to approve the JD LINK to be paid out of the Joint Equipment Fund for the total cost of \$600 with \$200 being the Authority's portion was made by Larry Nair, second by Doug Hoffman, all ayes, motion carried.

Derek informed the Authority that the Academy still had issues with their tank and they are still directly drawing from the system.

Ed Twine reviewed the correspondence and the calendar.
